LIMIT: One entry per class & two per division.

SPECIAL RULES:

- Each judging is limited to a total of 20 tables. Entries are accepted on a first-come, basis.
- Tables 3' X 5' will be furnished by the management. We recommend two to four settings. Linen, china, glassware, and flatware to be furnished by the exhibitor. Exhibitor to cover entire table with linen to allow drop on all sides. The management will take every precaution to assure safe return of these items; however, management will assume no responsibility, for loss or damage.
- No cut fruit, vegetables or perishable food is allowed.
- After the fair closes on Tuesday 10th The committee reserves the right to remove dishes and material entered in Division 136 which remain on the table. A box with wrapping for the dishes can be left with the superintendent.
- Emphasis should be on originality and over-all design.
- Tables will be judged from all angles.
- Entries may not have previously been entered in Southern California Fair.
- Three (3) entries per division. One (1) entry per class.
